GENDER POLICY

The college has formulated a gender policy to promote gender equity in all its endeavours.

Rationale:

Given the socio-cultural and economic milieu of the society, a strong supportive environment is needed in the college to ameliorate the conditions of the women students. As all human beings are born free and equal, in terms of dignity and rights, the institution should reflect the same theme in its structures and functioning, thus promoting gender equality.

Policy Statement:

The Gender Policy of the college provides a framework to realize and champion the cause of gender equality and women empowerment. The college strives to provide equal opportunities for empowerment of women, protect them against all forms of discrimination and violence. The Women Empowerment Cell, the Anti-Ragging Committee, and the Internal Complaints Committee, together, ensure the aforesaid objectives. - Awareness programmes on women empowerment were organized by inviting prominent women in different fields like Ms. Swathi Lakra, IPS.
- Awareness Programmes on nutrition and health for women are organized regularly to make women students and staff aware of the importance of women's health for a healthy society.
- > Programmes on the importance of self-defence training are conducted exclusively for women students and staff
- > Other initiatives like a certificate course on self-defence are also introduced.

- Awareness programmes against eve-teasing and sexual harassment at workplace are organized by the Internal Complaints Committee (ICC).
